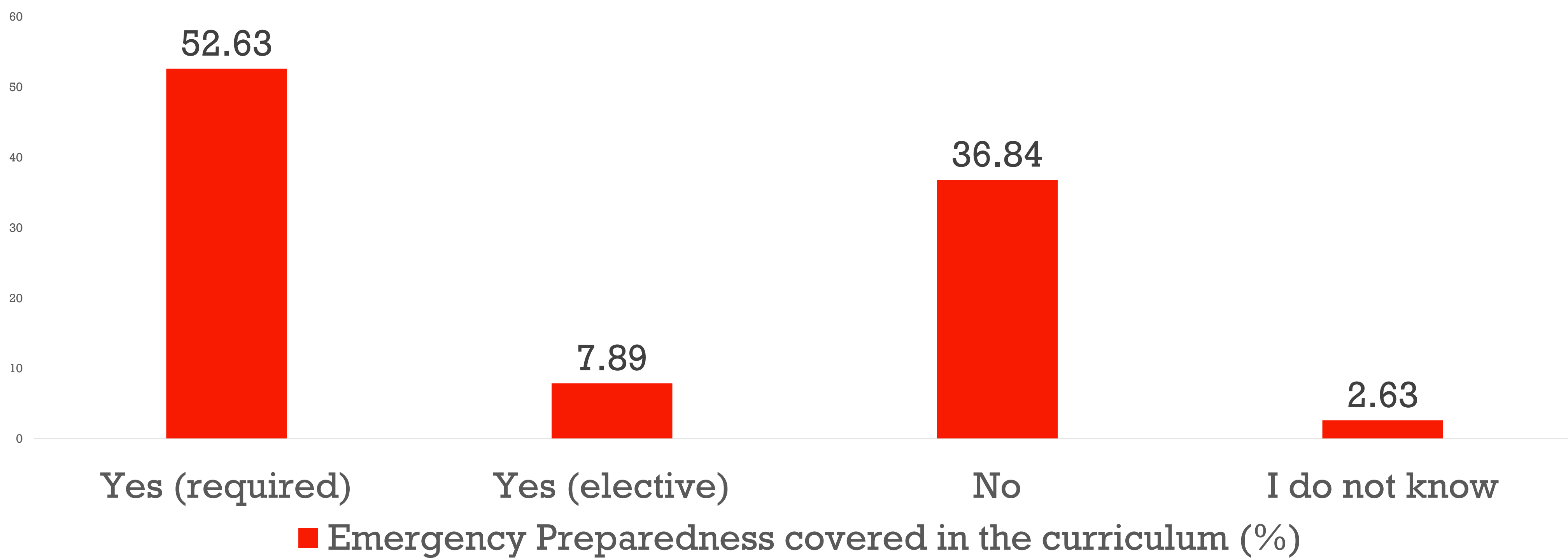
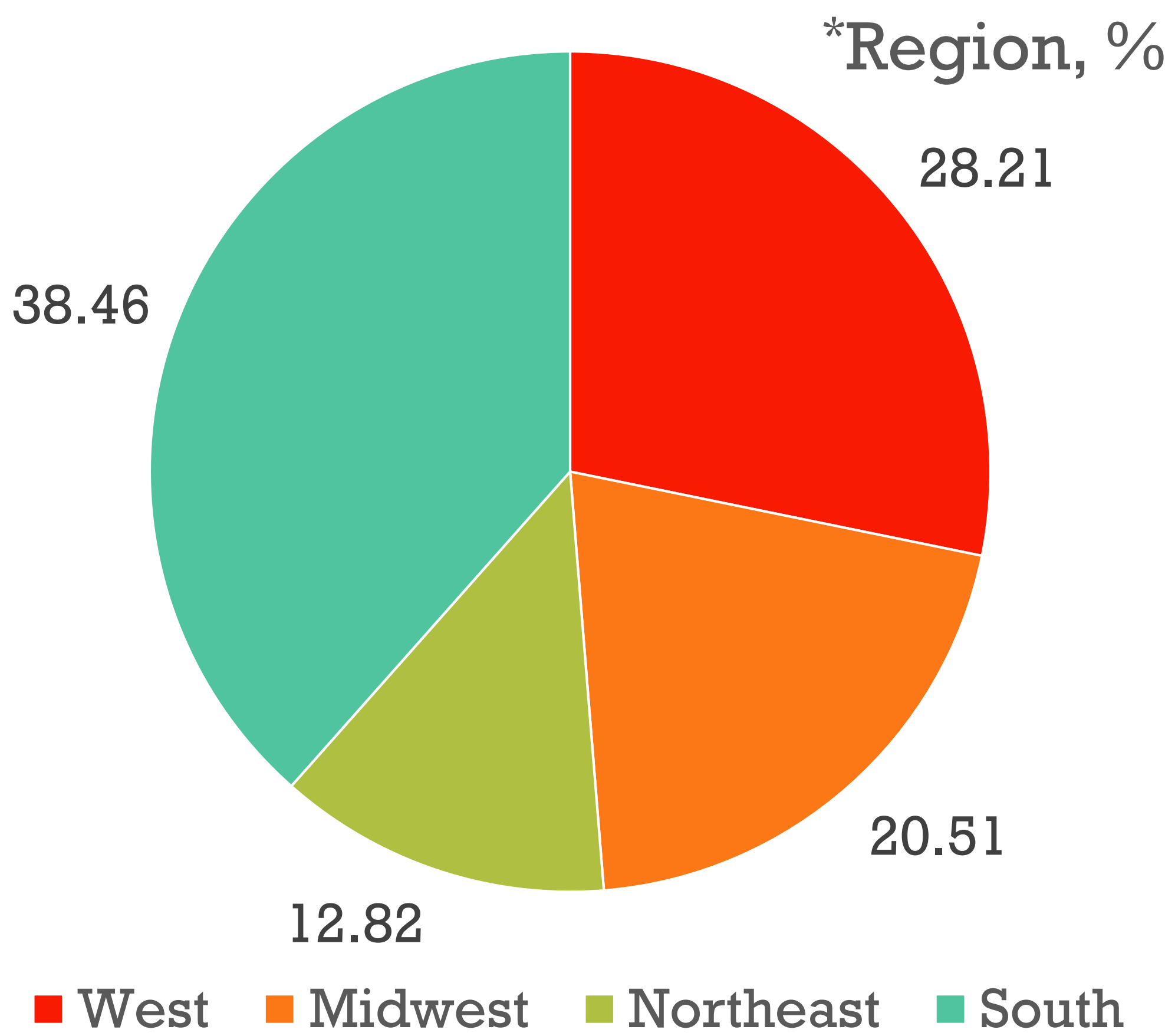

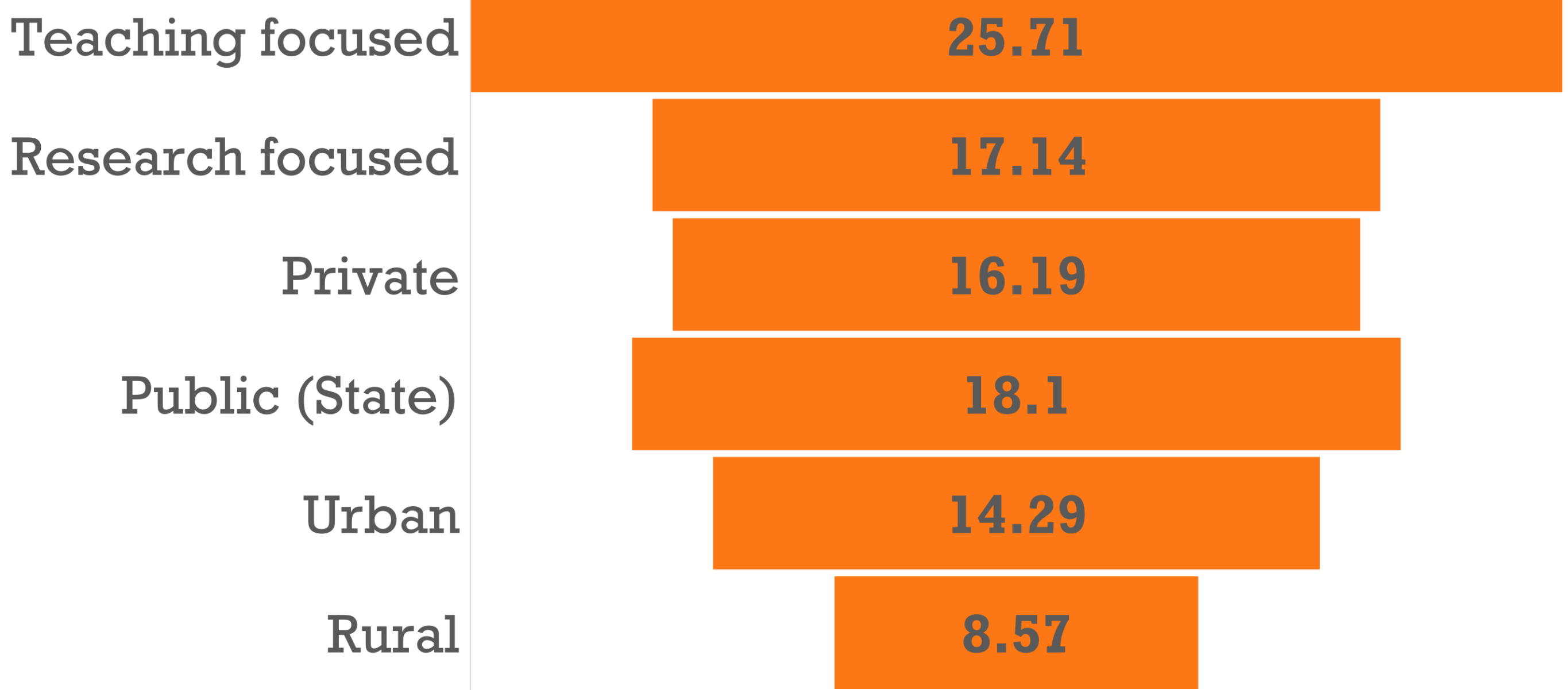

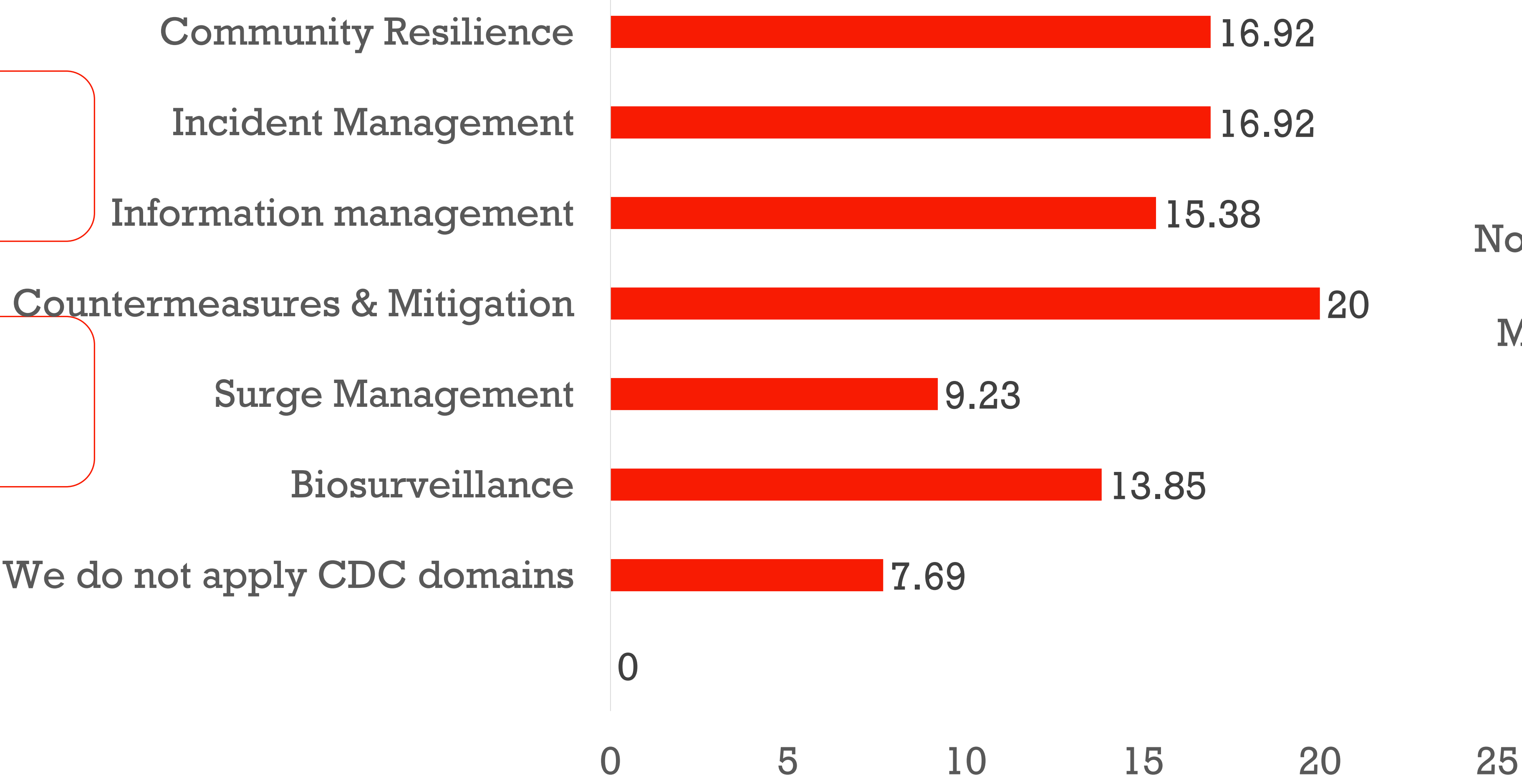

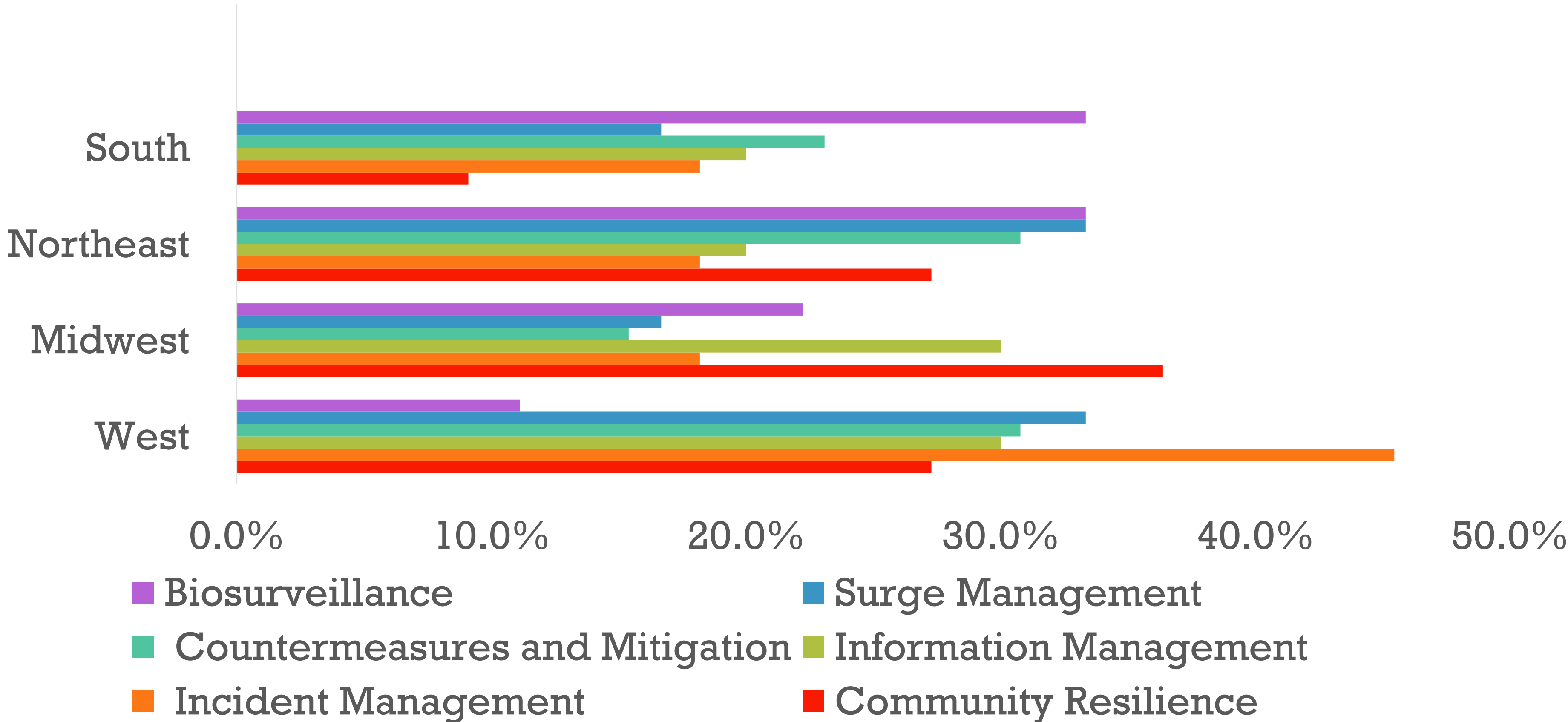
Type of University, %
