


Teaching to Advance Health Equity through the Quintuple Aim for Health Care Improvement Framework

Objective

- To apply the Quintuple Aim framework to courses that promote health equity in pharmacy education.

Methods

- An existing repository of Social Determinants of Health exemplars was utilized.
- The existing exemplar data set was mapped to the Quintuple Aims for Healthcare Improvement.

Background

- Health care is complex and impacted by upstream influences that lead to health disparities.
- Pharmacists must be equipped and ready to promote health equity.
- The Quintuple Aim considers key constructs that impact health equity.¹⁻³

Discussion

- Systemic change and holistic patient care require innovative teaching strategies.
- The eight courses/programs highlight most of the aims
- All course/programs covered Health Equity concepts.
- 75% covered Reducing Costs.
- 87.5% included Enhancing the Care Experience.
- Only 25% covered Clinician Well-Being.

Conclusion

- The majority of exemplars included the Quintuple Aims such as health equity, enhancing the care experience, reducing costs and improving population health.
- More work is needed to address workforce wellness.
